## CONSIGNMENT AGREEMENT

Welcome! We are pleased that you want to become part of our shop. We are committed to selling your items at the best possible price. Here is how it works:

We accept upscale, authentic women's and children's clothing, accessories, shoes, handbags and jewelry. We offer two options for consigning your items:

1. By appointment (please call 703-743-1494)
2. Fashion Fast Drop (no appointment necessary)

No matter which consignment option works best for you, the following guidelines apply:

- There are certain labels that we are not able to accept. A current list is available on our web site and in the **Notes** section of our Facebook page titled "*Labels We Do Not Accept*" as well as listed in our store. We will only accept clothing that is no more than 2 years old, except for classics like Chanel, St. John's, etc. Clothing is only be accepted on a seasonal basis.
- For **women's clothing**, we will accept 10-15 hangable items per appointment/drop-off. Accessories do not count towards that limit. For **children's clothing**, we will accept a maximum of 25 items per appointment/drop-off.
- All items should be clean, pressed, free of stains, no odors, no snags, holes, missing buttons, etc., and in current style.
- We do not accept faux designer knock-offs, business suits, bridal, lingerie, bathing suits, or athletic clothing/shoes. Sometimes there will be items that we cannot sell. Please understand that our customer's preferences must be our selection guidelines.
- We will keep the items for 30 days. We will reduce items by 15% after 15 days.
- We keep fine jewelry and higher end handbags for 60 days and pay the consignor 60%, instead of 50%.
- Items that are found to be unsellable once taken into our inventory (i.e. missing button, stain, hole, make-up, etc.) will be removed from the sales floor and donated on your behalf; the item will not be stored and returned to you.
- You will be responsible for locating and removing from the sales floor any unsold items that you may wish to keep, within 3 days of the expiration of your consignment period. If we do not hear from you within the 3 day grace period, your unsold items will then become property of The Very Thing For Her or will be donated. Please pick up your items Tuesday – Saturday; no retrievals on Sundays. Pick up times are 10-12 and 2-6.
- Donations, when applicable, are made on your behalf to The Friends of Homeless Animals and a Federal tax deduction form will be given to you at the end of the year (at your request).

- We base prices on supply and demand. We will try to get the best possible prices for you. You will receive 50% (60% on fine jewelry) of the selling price on the items that you bring in to consign. If you would like a set price on a particular item, please let us know. Items may be placed on Sale/Discount (i.e. End of Season or Special Event) at our discretion. Initial: \_\_\_\_\_
- We only issue checks at the end of your 30 or 60 day consignment period. You are welcome to pick up your check then, or if you would prefer, we can mail it to you. Of course, you may use the money in your account at any time for in-store purchases and you will receive 10% off your entire sale. You may check your account anytime at [www.myresaleweb.com](http://www.myresaleweb.com). This will allow you to see what has sold and what has not sold. It will also allow you to view your balance.

- Bring in on hangers (hangers will be returned to you).
- Items not accepted will be returned to you (or donated if you prefer).
- Items are not priced during your appointment.

**Fashion Fast Drop:**

- Place neatly folded garments in a shopping bag that you do not want returned to you, along with any accessories. We would prefer that the items not be on hangers. Fill out a Fashion Fast Drop form when you arrive at the store.
- We will not be able to look through your items at the time of your drop-off. If you would prefer this option, please schedule an appointment.
- Items that we are not able to accept due to the designer label, wear, age, stains, missing buttons, holes, etc. will be donated on your behalf to charity. We do not return unsellable items or the bag in which they were dropped off.

**We will do our best to safeguard your items, but we are not responsible for damage or loss.** We look forward to a long and mutually profitable association with you. After all, we could not do it without you, our partner in consigning.

By signing this agreement, you guarantee that you are the true and lawful owner of any and all merchandise consigned with The Very Thing For Her. You also guarantee the authenticity of all merchandise consigned with The Very Thing For Her.
